MEMBER INFORMATION:

Provide personal information related to the insured member.



Sign and date this section to confirm the accuracy and completeness of the information provided.

AUTHORIZATION FOR RELEASE OF INFORMATION:

Sign and date this section. Without your signature, we cannot gather medical information to process the claim.

ADDITIONAL DOCUMENTATION:

Include medical records clearly stating a diagnosis as well as all itemized bills, including admission and discharge dates and room and board charges.

WHAT HAPPENS NEXT?

However, any delay in the submission or follow-up of medical records may slow the claims process. When we receive your claim, a dedicated representative will be assigned to your case. This person will coordinate all requirements and keep you informed if any additional information is needed.

WHAT HAPPENS WHEN A DECISION IS MADE?

You will receive a written decision about your claim by mail. If approved, benefit payment(s) will be sent by check separately. If your claim is denied, you have the right to appeal the decision. You can request a secondary review and may be asked for further details to support your appeal.
